## FIMM Financial Report - 2022

I am proud to present this report on FIMM's financial activity in 2022. The year 2022 showed renewed activity following the COVID pandemic, but the acceptance of communication technology is making people think twice before travelling to conferences. This made FIMM's decision to have a web-based conference once a year very relevant.

From a financial point of view, this means more expenses on webinar and communications. At present, with the new members, this does not pose a problem.

In fact, several members that had fallen back on payments in 2022 settled their accounts, making FIMM's present situation better than it has been for many years.

But the question of what FIMM returns to its members is one that must entertain us during the coming year. This must include the vision meeting that we discussed for 2023 but didn't pull it off. Not dealing with this issue can make an organization irrelevant and lead to its death. Noteworthy are the members we seem to have lost contact with (Canada, Japan, Slovakia, Russia).
